Donation for Northern Territory Open Education Centre in Australia

INPEX CORPORATION (INPEX) today announced that INPEX, operator of the Ichthys LNG Project, and its Partners will donate AUD \$3 million towards the relocation and construction of the Northern Territory Open Education Centre (NTOEC), a secondary school providing distance education to more than 500 students of year 10 – 12 in some of the most remote parts of Australia's Northern Territory. The donation will assist the Northern Territory Government to update and expand this important facility.

The joint donation is the latest in a series made by the Ichthys LNG Project with a focus on education, training and employment to contribute to the social and economic sustainability of the Northern Territory.

It follows a AUD \$3 million donation in 2010 for the construction of the Larrakia Trade Training Centre and a AUD \$3 million donation to Charles Darwin University for the establishment of the Northern Australian Centre for Oil and Gas.

The school is scheduled to open in mid-2016.

About the Ichthys LNG Project

The Ichthys LNG Project is a Joint Venture between INPEX group companies (the Operator), major partner TOTAL and the Australian subsidiaries of Tokyo Gas, Osaka Gas, Chubu Electric Power and Toho Gas. Gas from the Ichthys Field, in the Browse Basin offshore Western Australia, will undergo preliminary processing offshore to remove water and raw liquids, including condensate. The gas will then be exported to the onshore processing facilities in Darwin via an 889km pipeline. The Ichthys LNG Project is expected to produce 8.4 million tonnes of LNG and 1.6 million tonnes of LPG per annum, along with approximately 100,000 barrels of condensate per day at peak. Detailed Engineering, Procurement and Construction (EPC) of the Ichthys LNG Project is ongoing and production is scheduled to commence by the end of 2016.
